

OFFICIAL CONTEST RULES & REGULATIONS

BACKGROUND: MVZEIF (doing business as the Metro Vancouver Zero Emissions Innovation Centre) a registered Canadian not-for-profit corporation with charitable status incorporated under the relevant laws of Canada (incorporation certificate 1294644-1, charitable registration 762832269 RR0001), having its head office in Vancouver, British Columbia.

The MVZEIF wishes the participant to advance the purposes of the MVZEIF as stated below by participating in this contest and campaign:

1. To receive, hold, invest, and maintain a fund or funds, and to apply all or part of the principal and income to qualified donees as defined in subsection 149.1(1) of the Income Tax Act (Canada);
2. To protect the environment for the benefit of the public by reducing and remedying the effects of greenhouse gas (GHG) emissions and other pollution that contribute to climate change by conducting or supporting programs for sequestering carbon, increasing use of low carbon materials and systems, increasing use of renewable energy, and energy conservation related to communities, buildings, transportation systems and industrial processes;
3. To advance education by providing or funding educational programs such as seminars, conferences, peer-network meetings, webinars, forums or training sessions to educate the public on the importance of and means of reducing, minimizing, or stopping greenhouse gas (GHG) emissions and pollution;
4. To advance education by conducting or funding research on methods to reduce GHG emissions and on potential means by which the harmful effects of pollution can be mitigated, reversed or curtailed, and disseminating the results of this research to the public; and
5. To do all such other things as are incidental and ancillary to the attainment of the foregoing purposes.

WHO CAN ENTER: This Contest is open to all persons who are legal residents of British Columbia on **May 13, 2024 08:00 PST (Pacific Standard Time)**. Contest is open to legal residents of British Columbia who have reached the age of majority in their respective province or territory of residence at the time of entry. Employees of the Sponsor(s) and immediate family members of, and any persons domiciled with any such employees or contractors, are not eligible to enter.

CONTEST PERIOD: The Contest starts on **May 13, 2024 08:00 PST** and closes on **June 24, 2024 23:59 PST**.

HOW TO ENTER: NO PURCHASE NECESSARY TO ENTER OR WIN. ONLY AN EMAIL ADDRESS is required. One (1) Entry per person. Entrants must live in British Columbia. By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor and Administrator. Void where prohibited by law.

Draw will be conducted on **June 25, 2024 12:00 PST in Vancouver, BC**. The odds of winning will depend on the number of entries received.
